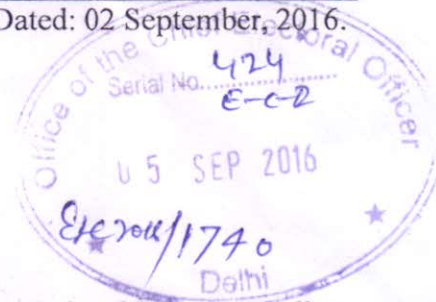

I am directed to state that on reviewing poll performance of the All India Trinamool Congress, as per the provisions of the Election Symbols (Reservation & Allotment) Order, 1968, it is seen that "All India Trinamool Congress" is presently recognized as state party in the states of West Bengal, Tripura, Manipur and Arunachal Pradesh and, consequently, fulfills the conditions laid down in Para 6B (iii) of the said Election Symbols (Reservation & Allotment) Order, 1968, for recognition as a National Party. Accordingly, the Commission has granted recognition to the "All India Trinamool Congress" as a National Party under the provisions of the Election Symbols (Reservation & Allotment) Order, 1968 and has allotted the symbol "Flower and Grass" as the reserved symbol for the party in all States and Union Territories.
