No. 464/DL-LA/2015: - WHEREAS, the Lieutenant Governor of the National Capital Territory of Delhi has, by notification issued under sub-section (2) of section 15 of the Representation of the People Act, 1951 (43 of 1951), published in the official Gazette of the National Capital Territory of Delhi on the 14<sup>th</sup> January, 2015 (Wednesday), been pleased to call upon all Assembly Constituencies in the National Capital Territory of Delhi, to elect members to the Legislative Assembly of the National Capital Territory of Delhi, in accordance with the provisions of the said Act and of the rules and orders made thereunder;


NOW, THEREFORE, in pursuance of Sections 30 and 56 of the said Act, the Election Commission of India hereby-

(A) appoints, with respect to the said election in each of the Assembly Constituencies specified as under :-


- (a) the 21<sup>st</sup> January, 2015 (Wednesday), as the last date for making nominations;
- (b) the 22<sup>nd</sup> January, 2015 (Thursday), as the date for scrutiny of nominations;
- (c) the 24<sup>th</sup> January, 2015 (Saturday), as the last date for withdrawal of candidatures;
- (d) the 7<sup>th</sup> February, 2015 (Saturday), as the date on which a poll shall, if necessary, be taken; and
- (e) the 12<sup>th</sup> February, 2015 (Thursday), as the date before which the election shall be completed; and

(B) Fixes the hours from 8.00 AM to 6.00 PM, as the hours during which the poll shall, if necessary, be taken on the date specified above, for the election.


**NOTIFICATION**
