2. The media Certification & Monitoring Committee at New Delhi district level have following members:



3. The scope & function of Media Certification & Monitoring Committee are as follows.

- (i) Certification of advertisement, monitoring of both print and electronic media in rotation to all advertisement /paid news/ election related news of the contesting candidates /political parties.
- (ii) To grant permission of any advertisement .The Committee shall forward a copy of the permission along with all expenditure details to concerned DEO and the accounting team for inclusion of the expenditure on shadow Observation Register.
- (iii) To see all newspapers, print media. Electronic media, cable network, mobile network and mode of mass communication like bulk SMSs etc and keep record of advertisements, advertorials messages, discussions and interviews related to the candidates and parties and submit a daily report with respect to each candidate
- (iv) To closely watch the campaign through Electronic /print Media including Cable network, Radio etc.
- (v) Any Other directives and instruction issued by Election Commission of India from time to time.

5. There is no fixed tenure for the members of the committee, District Election Officer (DEO), New Delhi District may alter/ amend the composition of the committee at any point of time.

6. The Headquarters of the Committee will be at New Delhi.


