

जनसाधारण की सूचना हेतु अधिसूचित किया जाता है कि लोक प्रतिनिधित्व अधिनियम, 1951 की धारा 135-बी के उपबन्ध के अनुसार, राष्ट्रीय राजधानी क्षेत्र, दिल्ली में किसी व्यापार, व्यवसाय, उद्योग, उपक्रम या किसी अन्य स्थापना में कार्यरत तथा मतदान के पात्र सहारनपुर, शामली, मुजफरनगर, बिजनौर, मेरठ, बागपत, गाजियाबाद, हापुड़, गौतमबुद्ध नगर तथा बुलंदशहर में रहने वाले प्रत्येक व्यक्ति को लोक सभा आम चुनाव, 2019 में अपना वोट डालने के लिए मतदान की तिथि 11 अप्रैल, 2019 को एक दिन का अवकाश प्रदान किया जाएगा।

उक्त अवकाश के कारण कोई भी वेतन काटा या रोका नहीं जाएगा यदि कोई व्यक्ति ऐसे आधार पर नियुक्त है कि उसे ऐसे दिन के लिए सामान्यतः कोई वेतन प्राप्त नहीं होगा तब भी ऐसे ही वेतन प्राप्त होगा जैसे उस दिन उसे कोई अवकाश नहीं दिया गया था।

उपरोक्त उपबन्धों का किसी भी प्रकार से उल्लंघन लोक प्रतिनिधित्व अधिनियम, 1951 की धारा 135-बी (3) के उपबन्धों के अनुसार दंडनीय है।

PUBLIC NOTICE

It is notified for information of the General Public that as per the provisions of Section 135-B of the Representation of the People Act, 1951, every person employed in any business, trade, industrial undertaking or any other establishment in National Capital Territory of Delhi and entitled to vote and residing in Saharanpur, Shamli, Muzaffarnagar, Bijnaur, Merrut, Bagpat, Ghaziabad, Hapur, Gautambudh Nagar and Bulandshahar shall be granted a holiday on the day of poll i.e. 11th April, 2019 so that he/she can cast his/her vote during General Election to the Lok Sabha, 2019.

No deduction or abatement of the wages shall be made on account of above holiday and if any person is employed on the basis that he/ she would not ordinarily receive wages for such a day, he/ she nonetheless be paid wages as he/ she would have drawn had not a holiday been granted to him/ her on that day.

Any contravention of the above provisions is punishable as per the provisions of Section 135B(3) of the Representation of the People Act, 1951.

NOTICE

Election Commission vide notification dated 18.03.2019 and subsequent letter No. 78/2019/EPS dated 22.03.2019 addressed to various States/UTs have notified the schedule of Lok Sabha Elections for various states. The first phase of Lok Sabha General Elections shall be held on 11.04.2019 in various States including UP.

In cases, where the persons who are ordinarily resident of and are registered voters in the Lok Sabha constituencies of U.P. which are going for polls on 11.04.2019, who may be employed in an Industrial undertaking, factories, shops and establishments, or any other business in Delhi should be granted one day paid holiday on 11.04.2019 enabling them to cast their vote in their respective constituencies in the State of U.P.

All such employers of Industrial Establishments/Factories/Shops and Commercial Establishments mentioned hereinabove should grant one day paid holiday to their employees on 11.04.2019 so that they can cast their vote in their respective constituencies.
