2. The sealed quotations in an envelope super scribed "Quotation for sale of condemned items" Address to ACEO (P&I) shall be received latest by 02/01/2024 till 10.00 AM in P&I Branch, Room No. 7, Office of Chief Electoral Officer, Old St. Stephen's College Building, Kashmere Gate, Delhi.
3. The received Quotations will be opened on same day at 12.30 PM in the Chamber of Addition Chief Electoral Officer – I, Delhi in presence of bidders, if any.
4. No bid either by post or in hand will be received after the specified time and date mentioned above. No extension of date & time will be allowed.
5. An Earnest Money/Bid Security of Rs. 5000/- (Rs. Five Thousand only) in the form of an Account Payee Demand Draft/Fixed Deposit receipt in favour of DDO CEO(HQ), Delhi will have to be deposited before/ along with submission of Quotations by due date in P&I Branch, Office of the Chief Electoral Officer, Old St. Stephen's College Building, Kashmere Gate, Delhi.
6. The condemned items will be delivered/ handed over to the successful bidder (H-1) within the office premises, only after deposit of full payment, on the same day with the DDO CEO(HQ).
7. The condemned items will have to be lifted within three (03) days of completion of successful bidding and after depositing the bidding amount. All costs including transport and labour will be borne by the bidder.
