PRESS NOTE

1. Special Summary Revision of Electoral Roll w.r.t. 01.01.2021 as qualifying date, has commenced in all 70 Assembly Constituencies of the NCT of Delhi with draft publication of electoral roll on 16.11.2020. Special Summary Revision-2021 will be carried out in accordance with the schedule prescribed by the ECI as under:-

The primary objective of the Special Summary Revision – 2021 is to include newly eligible voters w.r.t. 01.01.2021 i.e. who have completed or will be completing age of 18 on or before date 01.01.2021. Another objective for the Special Summary Revision-2021 is to give opportunities for correction in electors' particulars and also to invite objections against any wrong inclusion in the Electoral Roll.
