

FREQUENTLY ASKED QUESTIONS (FAQ) ON SPECIAL INTENSIVE REVISION (SIR) 2026

1	What is Special Intensive Revision (SIR)?	<p>The Election Commission of India, under Article 324, Section 21 of the Representation of the People Act, 1950 along with other applicable provisions of the Representation of the People Act, 1950, is empowered for preparation and revision of Electoral Rolls.</p> <p>To maintain the integrity of the electoral roll, the Commission orders revision of electoral roll before every election or as per requirement.</p> <p>This year the Commission has announced Special Intensive Revision (SIR).</p>		
2	What is the objective of SIR	<p>Since many changes have occurred in the existing electoral roll due to frequent migration which has resulted in electors getting registered in more than one place, non removal of dead voters the Election Commission announced the Special Intensive Revision with the objective that <u>No eligible citizen is left out and no ineligible person is included in the Electoral Roll.</u></p>		
3	What is the duration of SIR process in Delhi?	<p>The SIR in Delhi starts from 30.06.2026 and will end-up with publication of Final electoral roll on 07.10.2026.</p>

5 (a)	What are the procedures adopted for distribution/ collection of Enumeration Form?	<ul style="list-style-type: none"> ➤ The Booth level Officers (BLOs) will visit each house hold and distribute the pre-printed Enumeration forms in duplicate to the existing electors and guide them in filling up the form. ➤ In case of your absence, the form will be handed over to any adult member of your family or will be slipped in the house if house found locked. ➤ The electors will have to file the relevant details in the Enumeration forms and the filled in Enumeration form will be collected by the Booth Level Officers during the subsequent visit, for that the Booth Level Officer will make atleast 3 visits for collection of Enumeration Form. ➤ The Booth level officer will collect the forms and keep one copy of the Enumeration form with him/her and give an acknowledgement of receipt of form on the other copy of Enumeration Form, which is to be retained by the elector. 		

5 (b)	Can Enumeration Form be filled through online?	The Elector can also fill the Enumeration Form online and submit for which provision is provided in the ECI website https://voters.eci.gov.in .
6	What should I do if I did not receive my Enumeration Form (EF)?	<p>The Enumeration Form will be delivered by the BLO at the address registered in the Electoral Roll.</p> <p>An elector can contact the Booth Level Officer either over phone using the contact number of Booth Level Officer available on https://www.ceo.delhi.gov.in.</p> <p>Or</p> <p>Through the Book a Call with BLO option which is available in the website https://voters.eci.gov.in or ECINet Mobile App.</p> <p>Details of BLO will also be printed at the top of Enumeration Form.</p>
7	How do I check whether my name exists in the Electoral Roll of Last SIR held in Delhi ?	<p>Last SIR in Delhi was held in Year 2002.</p> <p>For the convenience of General public, voter list of last Special Intensive Revision held in year 2002 in Delhi has been uploaded on the website of CEO, Delhi at the link https://www.ceodelhi.gov.in/ElectoralRoll_2002.aspx</p> <p>Details can also be searched by using the “search by details” or “ search by “EPIC Number” or “ Polling Station” options available in the search facility of the portal.</p> <p>By EPIC No:https://www.ceodelhi.gov.in/ElectorSearch_2002.aspx</p> <p>By Elector Details: https://www.ceodelhi.gov.in/ElectorSearchByName_2002.aspx</p> <p>By Polling Station: https://www.ceodelhi.gov.in/ElectorSearchByPollingStation_2002.aspx</p>
8	How do I search my name if I have settled in Delhi after 2002?	<p>In case any elector has come from other State and settled in Delhi after 2002, his/her name will not appear in 2002 voter list of Delhi. In such case, electors can search their details on the ECI’s portal at following link: https://voters.eci.gov.in/searchInSIR/S2UA4DPDF-JK4QWODSE</p> <p>Steps: Upon opening of Portal, Select your State, District, Assembly Constituency, Electors Full Name in last SIR, Elector Relative Full Name, Enter Captcha and click on Search Button.</p>
9	What details of last SIR will be required to be filled in Enumeration Form?	Relative name, State Name, AC Name, AC Number, Polling Station No, Part Sr No. as appearing in the voter list of 2002/2003/2005 (year of last SIR held in that particular State, as the case may be) will be required for filling in the Enumeration Form.
10	What should be done if name of an Elector is not found in the Electoral Roll of last SIR.	In such cases, an elector can link himself/herself with his/her or relative’s entries in electoral rolls of the relevant last intensive revisions of the respective States/UTs as the case may be.

11	What if name of elector (self) or any relatives (father/mother/grand father / grand mother) could not be linked with electoral roll of last SIR	In such cases, Electors have to fill his/her particulars like date of birth, Aadhaar No. (optional), Mobile No, Father's/Guardian's Name, Father's/Guardian's EPIC No. Mother's details/Spouse details & return the Enumeration Form without filling last SIR details. He/she has to provide any of the 12 documents prescribed by the ECI upon receipt of notice from ERO during Notice phase i.e. 05.08.2026 to 03.10.2026, as the case may be.
12	What details are required to be filled in Enumeration Form in case of daughter in law whose name was not present in the electoral roll of last SIR.	The last SIR details of the Parents/grand-parents (मायका) of such applicants will have to be provided in Enumeration Form and not the details of Father-in-law/Mother-in-law.
13	What documents have to be provided alongwith Enumeration Form	During Enumeration phase, no document is required to be provided by the elector.
14	Where can I find help if I face issues with the Enumeration Form filling or to search the electors details?	The Booth level Officers (BLOs) visiting each house will guide in filling up the form and to search the elector details. The voters can also contact Toll Free Voter Helpline Number – 1950 or use Book a Call with BLO facility available in the website https://voters.eci.gov.in or through ECINet Mobile app. Name & No. of BLO will also be printed at the top of Enumeration Form. Helpdesks have also been setup both at District & AC level.
15	Will I receive an acknowledgement after submission of Enumeration Form?	Yes, the Booth level officer will collect the forms and keep one copy of the Enumeration form with him/her and give an acknowledgement of receipt of form on the other copy of Enumeration Form, which is to be retained by the elector.
16	Is it mandatory to provide Aadhaar number for submission of Enumeration Form?	No, providing Aadhaar number in the Enumeration Form is optional.
17	What is the procedure to fill Online Enumeration Form?	The Election Commission of India (ECI) has made a provision on its official website https://voters.eci.gov.in for the convenience of electors to fill up the Enumeration Form online. Electors can log in to the portal using their registered mobile number or EPIC number, and authenticate themselves by entering the OTP received on their registered mobile number. After login, they can select the option available under the caption "Fill Enumeration Form." This facility is available to all electors whose name in the electoral roll matches with the name in their Aadhaar card. Upon successful login, the elector is required to fill in the necessary details displayed on the webpage. After submitting the correct details, the system will redirect the elector to the e-sign page. An OTP will then be sent to the registered mobile number for authentication, and upon entering the OTP, the form will be successfully uploaded. All electors who have registered their mobile numbers and whose names match in both Electoral Roll and Aadhaar records are requested to make use of this convenient online facility.

18	If an elector or his/her entire family is out of station, then how the form can be submitted?	<p>If an elector or their entire family is out of station during the House- to-House Enumeration Phase, they may utilize the option of submitting online Enumeration Form which can be accessed through the Election Commission of India's official portal at https://voters.eci.gov.in</p> <p>This Facility enables electors to complete the process even when they are not physically present at their residence.</p>
19	What happens if the Enumeration Forms are not returned?	<p>Names of only those electors will be included in the Draft Electoral Roll whose filled in Enumeration Forms are received back by the BLO.</p> <p>For electors whose Enumeration Forms are not returned, the Booth Level Officer will identify the cause such as Absent/Death/Shifted/ Duplicate based on inquiry from nearby electors.</p>
20	What if I could not deposit Enumeration Form.	If Enumeration Form is not deposited to the BLO, your name will not reflect in the Draft Roll to be published on 05.08.2026.
21	My name does not appear in draft roll as I could not deposit enumeration Form in time. But I still need my name in the Final Roll.	If you are eligible and want to enroll yourself as an elector after publish of draft roll, you may file Form 6 during the period of claims and objection alongwith Declaration Form and other supporting documents prescribed by the ECI.
22	What if my name appears in two places?	<p>As per section 17 & 18 of Representation of People Act, 1950, No person shall be entitled to be registered in the electoral roll for more than one constituency or more than once in a constituency.</p> <p>If registered at more than one place, submit the Enumeration Form in the constituency only, where you are currently residing. Other entry will get deleted from the fresh Draft Electoral Roll.</p>
23	What are the documents to be submitted upon getting the notice?	<p>The ECI has suggested the below list of necessary supportive documents which may be provided by Electors.</p> <ol style="list-style-type: none"> 1. Any Identity card/Pension Payment Order issued to a regular employee/pensioner of any Central Govt./State Govt./PSU. 2. Any Identity Card/Certificate/Document issued in India by the Government/ local authorities/Banks/Post Office/LIC/PSUs prior to 01.07.1987. 3. Birth Certificate issued by the competent authority. 4. Passport 5. Matriculation/Educational certificate issued by recognized Boards/ Universities 6. Permanent Residence certificate issued by the competent State authority 7. Forest Right Certificate 8. OBC/SC/ST or any caste certificate issued by the Competent Authority 9. National Register of Citizens (wherever it exists) 10. Family Register, prepared by State/Local authorities. 11. Any land/house allotment certificate by the Government 12. For Aadhaar, the Commission's directions issued vide letter No.23/2025-ERS/Vol.II dated 09.09.2025 shall apply.
24	If a voter in the family is employed abroad or working in other city/State how the person's Enumeration Form can be filled up?	If a voter in the family is employed abroad or working in other city /State, an adult member of the family can fill up the details of that non-available elector in the Enumeration Form, they can sign on behalf of the elector and submit it to the Booth Level Officer.

25	What should a voter do after submitting the form?	After publication of the Draft Electoral Roll, voters must check whether their name has been correctly included in the draft electoral roll. Draft Publication will be done on 05.08.2026.
26	How will I know my Enumeration form was accepted?	Your name will be reflected in the draft roll.
27	How can a voter check if their name is included in the Draft Roll?	(a) By checking the Draft Electoral Roll available with the BLO/ or at Voter Center. (b) Through the ECINET mobile app (c) Through voters.eci.gov.in Draft Roll will also be made available on the CEO Delhi website.
28	What to do in case my name is not there in the draft list?	You may file Form 6 during the period of claims and objection alongwith Declaration Form and other supporting documents prescribed by the ECI.
29	Can a new elector who has completed 18 years, apply for inclusion of his/her name in the electoral roll now?	The new elector who has completed 18 years or will be completing 18 years as on 01.10.2026 can apply in Form-6 for inclusion of his/her name in the electoral roll along with declaration form for enrolment either through online or offline at voter centre. The blank forms will also be available with the BLO. These forms will be processed during the Claims and Objections period. These changes will be reflected in the final roll.
30	How do I update my address if I have moved to a new location?	BLO will not be able to distribute your Enumeration Form at your address registered in Electoral Roll as you are not residing there. Hence, your name will not appear in the Draft Electoral Roll to be published on 05.08.2026 for the reason "Permanently Shifted" and in the absence of submission of Enumeration Form. You may file Form 6 during the period of claims and objection alongwith Declaration Form and other supporting documents prescribed by the ECI for inclusion of your name at the shifted place/new location.
31	When will the final electoral rolls be published?	Electoral Roll will be published on 7th Oct 2026 and displayed at the Voter Center in physical form and will also be made available on the official website of CEO Delhi.
32	What if my name is still not reflected in the Final Roll	The applicant can file an appeal before the District Election Officer/District Magistrate of concerned District within 15 days.
