1. Draft electoral roll was prepared on the basis of information provided by the electors in the Enumeration Forms given to the BLOs. Draft electoral roll was published on 31.08.2026 which is available on the website of CEO, Delhi, offices of the ERO/AERO of Assembly Constituencies and at all the Designated Locations (Polling Stations). **Link for Viewing/Downloading PDF of Draft Electoral Roll is <https://voters.eci.gov.in/download-eroll?stateCode=U05>. 2. List of Absentee, Shifted, Dead & Duplicate (ASDD) electors prepared by the BLOs during House to House visits in consultation with the BLAs appointed by the recognised political parties is available on the website of CEO, Delhi at the following link: <https://ceodelhi.gov.in/ceodelhiasdd/>
3. Electors appearing in Draft Electoral Roll include those who have mapped /linked themselves with self or their progeny entries in electoral rolls of last SIR and also those who could not link themselves with the electoral roll of last SIR.
4. As per schedule of SIR, Notice Phase/Period of Claims & Objections is currently under progress. As per instructions, notices have been generated for those who could not be linked with the electoral roll of last SIR and also those having logical discrepancies.
5. List of electors to whom notices have been issued has been published alongwith the reasons, on the websites of CEO Delhi, District Election Officers and designated locations as per SIR orders. List of notices issued is available on the website of CEO Delhi at https://ceodelhinet.nic.in/ceodelhiweb/Notices_Issuedn.aspx
6. **All stakeholders are hereby informed that issue of notice does not mean that their names will be deleted from the electoral rolls of NCT of Delhi. Notices are being issued to above said categories to correct their data in ECINET. No name can be deleted without giving an opportunity of being heard and issuing a proper speaking and appealable order.**

7. Upon receipt of notices, these Electors may submit reply/requisite documents to the ERO/AERO concerned. It is pertinent to mention that the list of documents prescribed by ECI is only indicative not exhaustive. EROs/AEROs, being statutory authority will take final decision based on the available documents and report of BLO.
8. **There is sufficient time for the disposal of the notices till 29.10.2026 as per schedule of SIR 2026 and names of such electors will be included in the Final Electoral Roll to be published on 04.11.2026.**
9. With the objective of maximizing the enrolment of eligible electors, **Special Camps** were successfully organized at all Polling Station Locations of NCT of Delhi on **20.09.2026**. Next round of Special Camps at all Polling Station Locations of NCT of Delhi will be held on **27.09.2026 (Sunday) from 10.00 AM to 5.00 PM**. The electors may visit the Camps to avail Electoral Services. All Senior Citizens, females, Specially abled citizens may approach their BLOs/AEROs for any assistance.
10. Further, **Special Camps for Homeless, Transgenders & Sex Workers** have also been planned on **23rd & 24th September, 2026** from **5.00 PM to 9.00 PM** at all DUSIB Night Shelter and other pockets of homeless citizens in Delhi.
11. Any eligible person whose name is not present in the Draft Electoral Roll, may file Form 6 along with supporting documents during the **claims and objections period till 30.09.2026** to get their name included their name in the final electoral roll. The forms can be submitted in both offline mode to ERO/AERO/BLO or in the online mode through <https://voters.eci.gov.in> and **ECINET Mobile App**.
12. For ease of general public/electors, **additional AEROs** are being deployed across all Assembly Constituencies apart from EROs for smooth disposal of Notices and Claims & Objections.
