SHOW CAUSE NOTICE

Whereas, the registration of an Association/Body of individual citizens of India as a political party is governed by the provisions of Section 29A of the Representation of the People Act, 1951; and

Whereas, the purpose of registration of an association as a political party with the Election Commission under the aforesaid Section 29A is stated in that Section itself, i.e. to avail of the provisions of that part for the purposes of the Representation of the People Act, 1951, which means participation in elections conducted by the Commission under the said Act; and

Whereas, "the Political Parties" (as per list in Annexure-A) were registered as a political party under the said Section 29A, on an application made by the parties under the said Section; and

Whereas, the Commission, in exercise of powers vested under Article 324 of the Constitution of India and Section 29 A of the Representation of the People Act, 1951 has issued Guidelines for Registration of Political Parties that are binding on all political parties; and

Whereas, para 3 (xix) of the Guidelines for Registration of Political Parties mandates that the applicant for registration as a political party, undertakes that it must declare in the party constitution that the party shall submit its Annual Audited Accounts to the Commission; and

Whereas, as per the records of the Commission, the Political Parties (as per list in Annexure-A) did not submit its Annual Audited Accounts for the financial year 2021-22, 2022-23 and 2023-24 within the stipulated time period; and

Whereas, the Commission has issued guidelines on transparency and accountability in party funds and election expenditure in pursuance of the direction of Hon'ble Supreme Court of India in the case of Common Cause vs Union of India & Others (AIR 1996 SC 3081), mandating all political parties to submit the statement of all the Election Expenditure incurred by the party from date of announcement of election to the date of completion of election. The Statement has to be submitted in the proforma specified by the Commission within 75 days of completion of election in the case of General Election to the Legislative Assembly and within 90 days of completion of election in the case of General Election to the House of the People; and

Whereas, as per the records of the Commission, "the Political Parties" (as per list in Annexure-A) have contested General Election but did not submit in the proforma specified by the Commission, the statement of all the Election Expenditure incurred by them within the stipulated time period; and

Whereas, in the above circumstances, the Commission, in exercise of its powers under Article 324 of the Constitution of India and Section 29A of the Representation of the People Act, 1951, proposes to delist the Political Parties (as per list in Annexure-A) from the list of registered parties and

Whereas, before taking action as proposed above, the Commission has decided to provide to the said party an opportunity of making a representation/showing cause, if any, as to why the proposed action may not be taken;

Now, therefore, the Political Parties (as per list in Annexure-A) is called upon to make a written representation to the undersigned in this behalf if it so desires. The representation, if any, should be duly accompanied by an affidavit from the President or General Secretary of the party, and all supporting documents on which the party proposes to rely, and should reach the undersigned **latest by 09.10.2025.**

It is also stated that **the date of hearing for the said parties have been scheduled on 06.10.2025.** Such hearing should mandatorily be attended by the President/ General Secretary/ Head of the Party. If no reply is received from the party by the aforesaid date, it will be presumed that the party has nothing to say in the matter and the Commission will pass appropriate orders without any further reference to the party.

Subject: Notice to Registered Unrecognized Political Parties (RUPPs) - reg

Madam/Sir,

I am directed to refer to the subject cited above and to state that Political Parties are registered under provisions of Section 29A of the Representation of the People Act, 1951. After registration with the Commission, Political Parties are entitled to many benefits like:

1. Exemption from Income Tax (Under Section 13 A of IT Act)
2. Recognition (Under Para 6 of Symbols Order)
3. Common Symbol Allotment for RUPPs under Para 10B of Symbols Order
4. Reserved Symbol for parties recognized under Symbols Order
5. Nomination of Star Campaigners

2. Para 3 (xix) of the Guidelines for Registration of Political Parties mandates that the applicant for registration as a political party, must declare in its constitution that it shall submit its Annual Audited Accounts to the Commission. These guidelines have been issued by the Commission under Article 324 and are binding on all political parties, making it a mandatory compliance on the part of a political party. Thus, non-submission of the annual audited accounts violates the obligation undertaken by the party under its constitution. Additionally, not filing the Election Expenditure Statement by the party violates the guidelines on transparency and accountability in party funds and election expenditure issued by the Commission in compliance of direction of Hon'ble Supreme Court of India in the case of Common Cause vs Union of India & Other (AIR 1996 SC 3081) vide letter No.76/PPEMS/Transparency/2014 dated 14.10.2014.


3. Over time, a large number of Political Parties have been registered. However, it has come to notice that many parties (registered up to December 2018) have not submitted their Annual Audited Accounts for the last 3 financial years (2021-22, 2022-23 and 2023-24) **within the stipulated due date i.e. 30.11.2022, 31.12.2023 and 15.12.2024, respectively.** Further, these parties have contested elections but not filed expenditure reports within the stipulated time period i.e. **within 75 days in case of Assembly elections and 90 days in case of Lok Sabha elections.** A list of such RUPPs is enclosed at Annexure-A.

4. You are requested to serve a Show cause notice to the above-mentioned political parties and to get the notice published along with the names of the parties in the form of an advertisement in National and local newspapers. Further, wide publicity needs to be given in the media and social media as well.

5. You are hereby authorized by the Commission to hear such parties and after giving opportunity of being heard to such political parties, it is requested to establish with the support of documents/evidence presented by the party and your office records, whether the party had submitted the aforementioned reports within the stipulated time.

6. It is requested to send a detailed report accordingly to the Commission (as per proforma attached at Annexure-B) within a period of one month from the receipt of this letter.

Cleaning up of the Electoral System Continues

ECI delists another 474 RUPPs

Starts proceedings to delist 359 more RUPPs

1. Political Parties (National/State/RUPPs) in the country are registered with the Election Commission India (ECI) under the provisions of Section 29A of the Representation of the People Act 1951.
2. Under provisions of the Act, any association once registered as a political party, gets certain privileges and advantages such as symbol, tax exemptions amongst others.
3. Guidelines for registration of Political Parties mention that if the party does not contest elections continuously for 6 years, the party shall be taken off the list of registered parties.
4. As part of a comprehensive and continuous strategy to clean up the electoral system, the ECI has been conducting a nationwide exercise to identify and delist Registered Unrecognised Political Parties (RUPPs) which have failed to fulfil the essential condition of contesting even a single election for 6 years continuously, since 2019,
5. In the first phase of this exercise, ECI had delisted 334 RUPPs on August 9, 2025.
6. **In continuation, in the second phase, ECI delisted 474 RUPPs on September 18, 2025** based on non-contestation in elections conducted by ECI continuously for 6 years. Thus, 808 RUPPs have been delisted in the last 2 months. (Annexure-A)
7. To take this initiative further, **359 such RUPPs have been identified**, for having not submitted their Annual Audited Accounts in the last three financial years (i.e. 2021-22, 2022-23, 2023-24) within the stipulated time period and have contested elections but not filed Election Expenditure Reports. These are from 23 different States and UTs across the country. (Annexure-B)
8. In order to ensure that no party is unduly delisted, the CEOs of the respective States/UTs have been directed to issue show-cause notices to these RUPPs following which, the parties will be given an opportunity through a hearing by the concerned CEOs.
9. The ECI takes the final decision on the delisting of any RUPP based on the reports of the CEOs.
