Election Expenditure Monitoring Software-Guidelines for filing of DEO's Scrutiny Report

Election Expenditure Monitoring Software is a web portal system to help DEOs to submit candidate wise Scrutiny Report.

Steps for E-filing (DEO Login):

- 1. Open the link https://encore.eci.gov.in
- 2. Select "General Election to the House of People" or "General Election to the Legislative Assembly", depending on the election concerned.
- 3. DEOs will use the username, password and process which is used for Suvidha login.
- 4. There are two options (1) Fill DEO Scrutiny Report (2) Dashboard.
- 5. Click on "Fill DEO Scrutiny Report".
- 6. The list of candidates will be automatically populated from Suvidha data of the AC/PC and appear on the page.
- 7. Under the heading "Status" click on "Not Started" to open a form.
- 8. Fill in the form till part 3 and finalise.
- 9. Once it is finalised it gives the DEO the following option "Continue to add more DEO Scrutiny report for candidates" "Yes/No"
 - I. Pressing "Yes" will take the DEO back to the first page with the name of all candidates for entries.
 - II. Pressing "No" will take the DEO to the "Tracking Module"
- 10. Tracking Module to be filled.
- 11. Finalising the Tracking Module will take the DEO back to the landing page with the list of candidates for further entry.
- 12. Finalising the Tracking Module report shows the Status as "Finalised".
- 13. The finalised form will be pushed to the CEO for further necessary action.

Steps to be taken by CEO:

- 1. Open the link https://encore.eci.gov.in
- 2. Select General Election to the House of People or General Election to the Legislative Assembly depending on the election concerned.
- 3. CEOs will use the username and password which is used for Suvidha login.
- 4. After logging in click on "Expenditure" Tab.
- 5. There are two options (1) Notification (2) Dashboard.
- 6. Click on "Notification" to see Scrutiny Reports which have been pushed by DEOs.
- 7. The list of candidates pushed by the DEOs will be visible AC/PC wise.
- 8. Under the heading "Status" click on "Update Info" update comment and finalized
- 9. Finalising the Tracking Module will take the CEO back to the landing page with the list of candidates for further entry.
- 10. Finalising the Tracking Module report shows the Status as "Finalised".

Reference is invited to Commission's instructions dated 29 August, 2014* 76/PPEMS/Transparency/2013), dated 14 October. 2014** No. 76/PPEMS/Transparency/2014), and dated 19th January, 2024*** F. No. 76/Transparency/PPEMS/2023) (copies enclosed). Attention is also invited to Commission's letter dated 9th February, 2023 (F. No. 76/Transparency/RUPPs/FRs/PPEMS/2023) and letter dated 20th August, 2024 (F. No. 76/Transparency/RUPPs/FRs/PPEMS/2023). In this respect, I have been directed to draw your attention for strict compliance of Commission's aforementioned instructions on transparency and accountability in voluntary contribution and election expenditure of RUPPs.

- 2. In view of the above, it is reiterated that as per Commission's instructions dated 29th August, 2014 and 14th October, 2014, RUPPs are required to submit their Contribution Reports, Annual Audited Accounts and Election Expenditure Statements with the CEO of the State/UT where their party headquarter is situated. On receipt of the reports/statements, the CEOs of the States/UTs are required to perform following activities in respect of the reports/statements so received:-
- (i) Upload the scanned copies of the Contribution Reports, Annual Audited Accounts and Election Expenditure Statements on CEO website, within 3 days of receipt of the reports for viewing of the public, under heading "Reports and Accounts Statements of State Level Political Parties" with links from "Current News". {Heading on the website to be changed as "Financial and Election Expenditure Reports and Audited Accounts Statements of Registered Un-recognised Political Parties (RUPPs)}
- (ii) The list of reports/statements filed by the RUPPs be compiled and uploaded on the CEO's website within 24 hours of the due date in the prescribed proforma in Annexure A, B and C (copies enclosed). The list shall be periodically updated by the CEO office within 3 days of receipt of statement/report from any political party. The status report should have hyperlinks to the uploaded scanned copies of the concerned party's report/statement.

- (iii) A copy of the Contribution Report received from any RUPP shall be forwarded to the Pr. Chief Commissioner of the Income tax of the State/UT concerned mentioning the date of receipt of such report. The Contribution Report shall also be forwarded to the Ministry of Home Affairs for scrutiny and action on any donation received from foreign sources under Foreign Contribution (Regulation) Act, 2010. The Commission vide its letter dated 19th January, 2024 (copy enclosed) has also mandated for the CEOs of States/UTs to forward Contribution Reports of RUPPs to the Ministry of Corporate Affairs also.
- Annexures A1, B1, and C1 (copies enclosed), for every month by 10th of the succeeding month, and specifically mentioning that all the above-mentioned financial reports/statements and the lists prepared in Annexures A, B and C have been uploaded on the CEO's website, and the Contribution Reports of RUPPs have been duly forwarded to the concerned authorities.
- 4. Strict compliance of this instruction is to be ensured.

Sub: Forwarding Contribution Reports of Registered Unrecognised Political Parties (RUPPs) to the CBDT, M/o Home Affairs, M/o Corporate Affairs-Regarding.

Madam/Sir,

I am directed to refer to the Commission's letter no. 76/PPEMS/Transparency/2013, dated 29th August, 2014* and letter no. 76/PPEMS/Transparency/2014, dated 14th October, 2014** (copies enclosed) and to state that Registered Unrecognised Political Parties (RUPPs) are required to submit their Contribution Reports, Audited Annual Accounts and Election Expenditure Statements (part & full) with the Chief Electoral Officer of the State/UT where their party headquarter is situated. The detailed procedure for processing of these financial reports by the office of Chief Electoral Officers (CEOs) has been delineated in the letters referred above.

- 2. As per the existing instructions of the Commission in the above mentioned letter dated 14th October, 2014, the CEOs are required to forward the Contribution Reports of RUPPs to the Principal Chief Commissioner of Income Tax of the State/UT concerned mentioning the date of submission of such reports by the political parties and to the Ministry of Home Affairs, Government of India for appropriate action under relevant statutes respectively.
- 3. As you are aware, apart from other persons, political parties are also entitled to accept contribution form companies as mandated under Section 29B of the Representation of the People Act, 1951 (RP Act, 1951), with exceptions, as provided in the statutes.
- 4. The Commission, therefore, desires that from the FY 2022-23 onwards, the Contribution Reports received from the RUPPs by the CEOs shall be forwarded to three departments namely i.
