ORDER

Permission is hereby granted for vehicle No. RJ-06-UA-3802 (Mahindra XYLO) to be used as audio/video van in the Delhi General Assembly Elections, 2015 by the Aam Aadmi Party subject to the following conditions:

1. The permission is valid for the period of 16-01-2015 to 05-02-2015 between 6.00 AM to 10.00 PM except on 05-02-2015 till 5.00 PM and further subject to the terms and conditions/instructions of Election Commission of India & other authorities and provisions of The Representation of People Act, 1951.
2. The permit should be displayed in original, on the windscreen of the above mentioned vehicle at the time of campaigning.
3. The permit is non-transferable.
4. Any person or vehicle using any photo copy/Xerox of this permit will be prosecuted under relevant provisions of law.
5. The expenditure details such as cost of vehicle/hire charges, fuel cost, salary/wages of driver, etc. should be recorded in election expenditure register and the details should be provided to the concerned authority.
6. Only one poster/banner/hoarding or symbol is allowed to be used on the vehicle.
7. Necessary permissions should be obtained from competent authority for utilizing sound speaker service on the campaigning vehicle.
8. For playing any CD/DVD, permission is mandatory from MCMC, CEO office Delhi. Specific permission shall be obtained from MCMC, office of CEO, Delhi for playing any media advertisement.
9. Provisions of election Model Code of Conduct and above conditions should be strictly followed.
10. The certified copy of registration certificate of the vehicle shall be submitted in the CEO office and before plying of this vehicle necessary permission shall be obtained from Transport Department.
11. Whenever this vehicle will be used in any election meeting, road show or any public gathering, the applicant will have to obtain prior permission of the Police for organizing the same.
12. Before the vehicle is used, all necessary statutory permissions shall be obtained from all concerned authorities.
