CIRCULAR

It has been noticed that in some cases the purpose of appointment of Booth Level Officers are not being served because of lack of coordination between BLOs and general public in the polling station areas assigned to them. This has affected the process of receiving of claims in Form-6 especially of young citizens of Delhi in the age group of 18 to 19 years. This is not acceptable at all.

The BLOs are to constantly engage with the people in area for receiving claims and objections, House to House visit and checking of overlapping, migration, transfer/shifting, checking inclusion/ exclusion errors and updation of Electoral Rolls etc. as specified in Election Commission of India's instructions No.23/BLO/2006-PS-II dated 09.08.06 and No.23/Inst/2015-ERS dated 8th July, 2015. However, some BLOs are not making the desired efforts. Therefore, it has now been decided that the BLOs, who fail to justify their presence on the ground in terms of receipt of claims in Form-6 from eligible young citizens as well as in the form of engagement in the localities in time-bound manner, **will face action in accordance with Section-32 of the Representation of People Act, 1950.**

Concerned Electoral Registration Officers shall communicate AC-wise list of such BLOs by 15th November, 2017. Non-submission of the list will attract the action against the Electoral Registration Officers of concerned Assembly Constituencies. All such reports shall be submitted through District Election Officer concerned only.

This issues with the approval of the CEO, Delhi.
